## II. Veterans Certification Procedures

Veterans are expected to achieve Satisfactory Academic Progress (SAP) to obtain and maintain veterans' benefits at Fielding Graduate University.

The Veterans Benefits School Certifying Official (SCO) will obtain from the Office of Student Advising the veteran's SAP status (Satisfactory and Unsatisfactory are the two possible outcomes).

Veterans who are reviewed and not found to be meeting SAP standards for the first time will be placed on Financial Aid warning/probation. Veterans on Financial Aid probation are still eligible for VA benefits.

Veterans who are reviewed and not found to be meeting SAP standards for the second consecutive review period will be placed on Financial Aid disqualification. Veterans on Financial Aid disqualification are not eligible for VA benefits.

Benefits cannot be certified retroactively for periods of Financial Aid Disqualification.

Once a student regains SAP, they may be eligible for VA benefits again.
